Kaya limited Q3 FY18 results Consolidated Revenue up by 3%

Kaya Limited posted consolidated Revenue from Operations of INR 100.3 crores for the quarter ended 31st December 2017, a growth of 3% over corresponding quarter ended 31st December 2016.

India business reported a Revenue growth of 8% and International business Revenue de-grew by 1% respectively.

Consolidated Operating EBIDTA is INR 1.4 crores (1% of Revenue), for the quarter ended 31st December 2017, as compared to INR (9.1) crores (-9% of Revenue), for the corresponding quarter in previous year.

Consolidated Profit after Tax for the quarter ended 31st December 2017 is INR (3.9) crores compared to INR (10.7) crores for the corresponding quarter ended 31st December 2016.
