Q1 FY20

Kaya Limited posted consolidated Revenue from Operations of INR 100.5 crores for the quarter ended 30th June 2019, a decline of 3% over corresponding quarter ended 30th June 2018.

India business reported a Revenue decline of 1% and International business declined by 6% over Q1 LY

Consolidated Operating EBITDA at INR 13.5 crores for the quarter ended 30th June 2019, as compared to INR 6.9 crores for the corresponding quarter in previous year.

Consolidated Loss after Tax and Minority Interest and exceptional items for the quarter ended 30th June 2019, is INR 9.6 crores compared to INR 0.4 crores for the corresponding quarter ended 30th June 2018.
